Details: The 6K race is run in memory of the runners we have lost to illness and accidents and named for our departed friend and great runner, Ron Landen. In memory of Ron, **runners are asked to wear Orange.** We will also run a GPS 4K as part of the Dawg Days series. Using GPS, run 2.48 miles anywhere on the property. A measured 4K course will be available as an option. Dirt roads.

AWARDS/ Shirts: All preregistered runners receive an orange cotton shirt. Race day shirts- as long as they last. Plaques to division winners. Perhaps something in obnoxious orange to all others. Double Pts in 3 Grand Prix series.
